1. Fees paid are for tuition provided by ELLSO, and the use of facilities and accommodation provided by Uppingham School.
2. Choice of accommodation is subject to availability and will be confirmed separately.
3. If you wish to amend your accommodation choice please notify us as soon as possible. We cannot guarantee that all requests will be fulfilled.
4. Your place will only be reserved once a completed application form is received and your deposit or payment in full has been processed.
5. If we cannot initially offer you a place, we will put your name on the waiting list and hold your payment. We will notify you should a place become available. If you have been put on the waiting list, you may withdraw at any time (subject to clause 8) and your payment will be returned to you.
6. All fees must be paid in pounds sterling.
